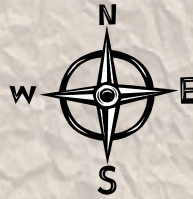

From US 131 N: Proceed north on US 131 N past Kalamazoo to Exit 55 (Hwy 222). Take the exit and turn left, continuing on Hwy 222 for 9 mi. Turn right on N. Main St. (turns into 30<sup>th</sup> St. (A37) and proceed 5 mi. Turn Left onto 125<sup>th</sup> Ave and go 1 mi. (If you reach Dumont Lake Rd you've gone about 0.1 miles too far). Camp is on the Left.
